IMPORTANT NOTICE - RESTRICTED BREED DOGS

The State Government has recently made significant amendments to the Domestic Animals Act 1994 in relation to the keeping of "RESTRICTED BREED DOGS".

A "RESTRICTED BREED DOG" means a dog of a breed whose importation into Australia is prohibited under the Customs (Prohibited Imports) Regulations 1956 of the Commonwealth.

These breeds currently are:

Dogo Argentino Fila Brasileiro Japanese Tosa American Pit Bull Terrier Pit Bull Terrier Perro de Presa Canario

The Act requires that if you are the owner of a "RESTRICTED BREED DOG" as identified above, you must notify Council by making a declaration (See Below). On receipt of the declaration Council will then formally advise you of the current requirements of the legislation in the keeping of "RESTRICTED BREED DOGS".

FAILURE TO COMPLY WITH THE LEGISLATION REQUIREMENTS MAY RESULT IN A \$1612 PENALTY BEING INCURRED.

ALL DOGS AND CATS OVER THE AGE OF THREE MONTHS MUST BE REGISTERED. COMPULSORY MICROCHIPPING. ALL CATS AND DOGS BEING REGISTERED WITH A VICTORIAN LOCAL COUNCIL FOR THE FIRST TIME MUST BE MICROCHIPPED PRIOR TO REGISTRATION. YOU CAN BE FINED IF YOU DO NOT COMPLY.

THE OWNER OF ANY DOG OR CAT NOT REGISTERED BY THE 10TH APRIL EACH YEAR SHALL BE LIABLE TO BE PROSECUTED. INSPECTION OF PROPERTIES MAY BE MADE AND THE AFOREMENTIONED PENALTIES WILL BE ENFORCED WHERE APPLICABLE.
