From 1 Dec 2020 - Emergency Management Legislation Amendment Act 2018 (2020) comes into force:

1. Municipal Emergency Management Planning (MEMP) Committee to be Chaired by WWSC CEO or his nominated Council Officer (ie: not a Councillor).
2. Municipal Fire Prevention Committee to be repealed, MEMP can create and appoint an MFPC Sub-Committee, if it chooses.
