






### **Strategic Context**

### **Purpose & Process of Master Plan**

Undertaking a 'Play spaces Master Plan' for the Edenhope township is an opportunity to develop a set of principles and strategic directions regarding the future provision of play. The findings of this project will be used to determine the optimum number, location and focus of Council's play spaces.

This will also mean providing a structured program for staged upgrades, renewal of existing infrastructure and installation of new infrastructure within the play spaces identified for etention and development in the master plan. It may also determine the removal of any play spaces where better provision can be built upon and provided at another existing play space and if play equipment is removed, what other forms of recreation may replace it.

The master plan will provide a basis for funding applications to state and federal government for the implementation of discrete elements, depending on the requirements of the funding brief.

Council has set some clear objectives for the project divided into 4 specific categories; physical, social, environment and economic and they are summarised below:

#### **Physical Objectives:**

- Develop play spaces that link together and allow for a range of gross-motor, sensorimotor, fine
  motor activities, with graduated challenge for a range of age groups and open space to run
  around and play games
- Develop play spaces that have elements that encourage creative and imaginative play
- Develop play spaces that encourage learning and testing, in particular ensuring there are loose materials available for play
- Create connections and layers within play spaces that encourage deeper exploration

### Social / Community Objectives:

- Develop play spaces that have access for all abilities and ages
- Develop play spaces that contribute significantly to the health and wellbeing of the community and encourage pride and a sense of ownership.
- Develop interesting, comfortable and safe play spaces.
- Develop clear linkages to and between the open spaces within the township.
- Embed with the play spaces a recognition of Edenhope's cultural heritage and the elements that make it unique.
- Develop interpretive play equipment, furniture or art that can be utilised by all age groups and demographics.

### **Environmental Objectives:**

- Develop sustainable design concepts to reduce impacts on the environment, including the incorporation of natural and recycled / re-purposed materials (where possible and appropriate, a reduction in water use where possible and the incorporation of water re-use ideas
- Develop play spaces that enhance the appreciation of the natural environment and where suitable include natural features and planting
- Develop play spaces that protect local heritage (including aboriginal and environment)

### **Economic Objectives:**

- Develop play spaces that provide additional community value and bring more locals and visitors into Edenhope, thereby improving local commerce and increasing township business
- Create 'flow on e fects' from improved local commerce and township business, by increased local employment and
- Create 'flow on e fects' from improved local commerce and township business by making Edenhope a 'destination' with broader tourist development to attract commuters or travelers on the Wimmera Highway to 'stop and stay'.

• Source goods and services required during the project's implementation phase locally where possible.

### **Environment & Character**

#### **Local Town Character**

Edenhope is a small, quiet rural service centre located on the banks of Lake Wallace and surrounded by fertile and undulating Wimmera country which is primarily used for sheep and grain. It is the administrative centre of the West Wimmera shire and is located on the Wimmera Highway only 30 km from the South Australian border.

Edenhope has developed mainly as a cropping and grazing area. Several large properties have been subdivided for smaller family farms, particularly for soldier resettlement after World War II. At that time the town's population reached nearly 1000, compared with about 450 in the 1930s. The school was raised to higher elementary standard in 1946 and a high school began in 1959. The year before, the town began its annual Henley on Lake Wallace boat regatta.

Edenhope has a district memorial hospital, elderly persons' facilities, a racecourse, a golf course, boating and fishing facilities in Lake allace, and tennis, swimming and bowling facilities. As well as the State combined primary and secondary schools, there is a Catholic primary school. There are Anglican, Catholic, Lutheran and Uniting churches. The lake has foreshore parkland and there is a reserve adjoining the showground; the racecourse is west of the town, near the aerodrome. Edenhope's tourism and information centre is in a former court house, and the town has a hotel, a motel and a caravan park.

### Lake Wallace (Connadoyen)

Lake Wallace sits on land belonging to he traditional owners of the area - the families of the Wotjobaluk, Jaadwa, Jadwadjah, Wergaia and Jupagulk. They call the lake 'Connadoyen'. It is a freshwater lake located in central Edenhope, which has in the past been for domestic water use. The lake covers an area of around 200 ha, is only a five minute walk f om Edenhope's main street. The lake was named after the legendary Scottish revolutionary, William Wallace. It is an ideal spot for boating, water skiing, swimming and fly-fishing for edfin and t out. At times of extreme drought it dries up. It was completely dry during the millennial drought and with the rains of 2016 (a particularly wet year), filled again. The e is a jetty and several boat ramps. Lake Wallace is also a waterbird haven that hundreds of birds visit and nest. There are bird hides and a 5 km scenic walking track around the lake.

In 1866, Australian cricketer Tom Wills trained a team of Aborigines on the lake's banks. The team played throughout Victoria and New South Wales, and several members formed the Aboriginal team which toured England in 1868.

Other significant waterways include Back Swamp (ephemeral wetlands connected to Lake Wallace through Lions Park) in Edenhope and in the wider district Lake Bringalbert, Lake Charlecrark, Lake Ratzcastle, Miga Lake and Newlands Lake.

### Environment Character & Biodiversity Landform

This is a landscape of flat to slightly undulating alluvial clay plains c eated by sweeping aeolian (wind-blown)sand dunes and ridges, with shallow swales forming between. Crescent-shaped lunettes are common along the northern and north eastern edges of low lying lakes and wetland areas.

#### Waterform

This region is exceptional for the number and diversity of lakes, swamps and wetlands dotted throughout the terrain between Horsham and Edenhope. These vary from chains of small, shallow depressions to larger lakes such as Lake Wallace. The formation of these lakes and wetlands is primarily due to a lack of channelled drainage and there are very few creeks or rivers where they exist as a result.

The Wimmera-Mallee Pipeline is a significant infrastructu e project in this region. By enabling a more efficient use of water in fa ming and irrigation, the pipeline may reduce the need to graze wetlands and use them as a water source.

### Vegetation


Though the landscape has been heavily cleared for agricultural production, numerous stands of vegetation remain scattered throughout paddocks, within the roadside reserves and conservation areas, and along rivers, creek lines and property boundaries. Of these, remnant River Red Gums (in the southern areas) and Buloke trees (in the northern area) are the most prolifi species.

There is a large number of state parks and bushland reserves, particularly in the western region. These are often concentrated around wetlands and other water bodies, and in reserves of vegetation along the ridgelines. Very little exotic vegetation is evident, with occasional shelterbelts or Cypress planting along driveways.

### Significant Habitat

The bird population in Edenhope is significant – with over 100 species of birds noted. This includes the rare Red-tailed, Black Cockatoo. The 'Icons of Edenhope' bird murals in the main street show the diverse local bird life.

The Growling Grass Frog (Litoria raniformis) inhabits both the Back Swamp and Lake Wallace and the connecting ephemeral creek that goes through Lions Park.




**Above: West Wimmera EVC Map**Courtesy of www.biodiversity.vic.gov.au

### **Purpose and Assessment Method**


Detailed site appreciation was undertaken by 3 x 20 Studios on Tuesday 16th November and Thursday 9th December 2021 at 5 specifically identified sites, Anne S eet Park, Apex Park, Henley Park, Lake Wallace, and Lions Park - where the present infrastructure is managed by West Wimmera Shire Council. Post-consultation several other sites identified by community members we e also visited and are noted in this report.

The purpose of assessing existing sites for play is to establish issues and potential, in particular where future improvements can be made.

The assessment process involved working through a prescribed checklist on site to note and score from 0-5. Zero 'being not present' to 5 being 'excellent and above average'. Photos were also taken to capture individual aspects of each site.

It's important to also note that being a strategic project, walkability and access connections between each of the sites and key local community facilities have also been assessed as important to ensure a good balance of local play suitable for different ages and locations.

#### **OVERALL SCORES - Edenhope Playspaces**



Not Suitable	Poor	Average	Good	Excellent

**Not Suitable:** Means the play space is either missing, unsafe or unusable. No universal access.

**Poor:** Means there is minimal play or supporting infrastructure available and available play is severely limited by range, choice and quality of equipment or landscape setting. Limited or no universal access.

**Average:** Means there is a small range of play and supporting infrastructure available, usually for a limited age group and with some choice. Standards equipment and landscape setting. Limited universal access.

**Good:** Means there is a much broader range of play and supporting infrastructure present, and there is integration with landscape setting. Still limited quality, but more available for different ages and some universal access present.

**Excellent:** Means play space is well considered and engaging, with a broad range of different types of play for different ages. Well developed level of accessible amenity and play, good supporting infrastructure. Well integrated and makes use of landscape setting for play.

### Areas of Investigation:

### Play Type:

Investigates how well-designed, complex and diverse in experience play activities are. It also checks that elements are fit for pupose and in good condition.



### Play Value:

Investigates the quality of the play space - do many different opportunities exist for a high-quality play experience and does the play space capture most types of play (physical, social, imaginative and cognitive) regardless of scale.



### Age Range Suitability:

Investigates the suitability of the play space for particular ages and the provision of enough quality play for all ages across the play network.



#### Access:

Investigates the provision and quality of universal access to amenity and play. Does the play space welcome everyone in the community?



### Play space Context:

Investigates the quality of the natural or designed landscape setting and opportunities used to integrate it with play.





Summary of Key Findings:

Background & Site Assessments

### **Summary**

Key findings for consideration in the development of the Play Spaces Master Plan for Edenhope are as follows:

- There is alot of opportunity with the current open space at all sites, given established trees and lakeside views at some sites
- Better connections are required between all play spaces, in particular from the central township north to Lake Wallace and from the schools to the west. This may be achieved by path connection, signage or markers (could be art treatment or elements) and visual connection
- Accessibility is poor at present and needs to be seriously considered at all sites in the form
  of sealed paths that seamlessly connect with seating, picnic tables, drinking fountains
  and bins. Where possible (and particularly with higher profile sites at Henley Park and
  Lions Park) provide integrated accessible paths and inclusive play within
  the play space
- All playspaces are underdeveloped and old and require upgrades to equipment to
  provide a broader range and greater complexity of play opportunities at individual sites,
  that makes the most of the local environment and is better integrated with the
  landscape
- There are presently very limited opportunities for children under 5 years, this needs to be a consideration given young families and visitors to Edenhope
- There are too many sites within a very small walking distance, key sites are Lions Park, Lake Wallace and Henley Park and some reconsideration of the future of these facilities needs to be undertaken. Consideration as to whether there are other opportunities for play (formal or informal) in alternative town locations
- Consideration should be given to conversion of Apex Park into a 'civic gateway park' rather than a play space with a focus on social interaction
- Anne Street Park should possibly be reconsidered as a space for informal nature play and / or for families with younger children
- Fitness equipment along Lake Wallace Foreshore needs to also be reconsidered as to whether it should be consolidated or continue to be located as stations along the existing Lake Wallace Foreshore perimetre path
- Lions Park needs to be redesigned as well as upgraded. The drainage line / ephemeral creek channel needs to be re-imagined without fencing as a softer, more natural treatment (utilising particular vegetation to support Growling Grass Frog habit), boardwalk and bridge crossings. Safety requirements around waterway to be considered as more integrated infrastructure
- Henley Park is presently dissected by service road. Re-thinking or removal of this road would enable expansion of play space and clearer / safer connection between all facilities onsite and make the entire site more user-friendly - particularly to local families living or visiting Edenhope
- All sites should be redeveloped to showcase the natural environment and support local flora and fauna. Mo e natural shade is needed at Henley Park and along Lake Wallace Foreshore

# 3. Community Engagement I:

Information Gathering



### **Community Engagement - Stage 1**

### What we did

On Thursday 9th of December 2021, Felicity Brown from 3 x 20 Studios visited Edenhope to meet with the local community and gather information.

The sessions included school students from Foundation Grade & Grades 1-6 and Year 7-8 at Edenhope P-12 College and Grades Prep-6 at St Malachys Primary School, then meet with families from Edenhope Kindergarten and lastly meet with adult community members.

The structure of the sessions were question based, and used plans showing the locations of all the play space to prompt conversation and feedback. This report documents and seeks to disseminate and utilised feedback received from the Edenhope community.







Apex Park


is mostly frequented by older children



# Community Online Survey I Information Gathering

An online survey was conducted using Survey Monkey on Council's 'Have Your Say' page on its website for 2 months from December 2021 - end January 2022. Overall the response to the survey was terrific - with 93 survey esponses received in a township of 946 or 9.8%. (ABS Census Data 2016)



#### 3.1 Graph of where the community like to play




**3.2 Graph of local aspects the community love about Edenhope** Total respondents 93/93



**3.4** Graph of preferred site and what the community liked about it Total respondents 92/93








**3.7 Graph of the distribution of community families' ages** Total respondents 93/93




# 10. How do you usually get to play spaces in Edenhope from home?

Summary of Key Findings:

Community Engagement 1

### **Summary**

Key findings for consideration f om the Community Engagement in the development of the Play Spaces Master Plan for Edenhope are as follows:

- Lions Park is most visited and valued park / play space in Edenhope. The age of equipment, lack of toilet facilities and obtrusive fencing around ephemeral creek / drainage channel are seen as problematic, but the community support better planning and design here
- There is a desire in the community for better and safer play opportunities at Lake Wallace
   given the toilet and picnic facilities at Henley Park. The organisation of the area and internal service road there is
- All play spaces are considered out of date, with not enough variety or interest to meet the community's current and future needs
- **Toilets** (within easy walking distance), well considered **fencing** and **shade** are seen by the community as highly desired
- Lake Wallace is highly prized by the community and many think more should be done to increase its value to both local residents, traders and visitors to Edenhope and to make the most of its natural / ecological features
- Tourism in extremely important to the commerce of the township particularly at Lake Wallace, this consists of visitors passing through and those who come to Edenhope for camping / caravaning holidays
- Students (who participated in school workshops) feel that the most important play
  activities to consider when improving Edenhope's play spaces are Swings, Agility / Up
  per Body Play, Slides, Spinning / Rotation Play, Bouncing (Trampolines),
  Imaginative Play and Cycling & Walking
- A larger proportion of students who participated in workshops lived outside of the Edenhope township on average (16 in 25), whereas survey respondents who lived in town tended to be more than half (63.44%). There appears to be a need to support both walking and driving to play spaces, with added reference to a desire for more opportunities to cycle as well
- There is support in the feedback for both water play and nature play, including natural and loose materials used in play spaces
- Of the responses for Question 8 'Do you, or any member of your family have additional needs we should be aware, several answers referred to mobility and recreation considerations for seniors
- Spaces that are age-appropriate are highly desirable, particularly for younger children. The largest number of respondents to the survey had children aged between 0-6 years
- If families were visiting play spaces outside of Edenhope they tended to be at: Harrow, Goroke, Kaniva, Naracoorte, Beachport, Millicent, Horsham and Lake Pertobe in Warrnambool
- There was support for recent upgrades by council of play spaces / parks at Goroke and Kaniva


# Edenhope Community Advisory Group

Key feedback on the Preliminary Schematic Plans for the Play Spaces Master Plan for Edenhope are as follows:

Overall there were up to 55 survey responses received and three submissions also received in a township of 946 or 5.8%. (ABS Census Data 2016)









I have reviewed the Mater Plan for Lions Park, in particular the proposed works around the drain. In principle we support the installation of additional habitat and vegetation into the drain and the planting of local EVC plants around the park.

The proposed works fit with the work we have been doing with West Wimmera Shire Council and the implementation of the Lake Wallace Strategic Plan. Wimmera CMA would be happy to provide advice and assist with the implementation of the Master Plan as required. We currently have an MOU in place with Vicroads to reuse timber from road projects for environmental purposes. If you require any logs for the proposed habitat, we would be able to access this.



#### **Dear Councillors and Staff**

I am writing to inform you that Edenhope Tourism Inc have had meetings with different community members of different demographics related to the Henley Park Proposal.

It has been pointed out by Sarah Ellis that the project is a long-term project. The group don't believe it will be because they have seen in the past how projects get rushed through.

We are asking WWS Councillors and Staff to respect and listen to voices of the Edenhope Community.

There are 3 other play spaces around Edenhope and the wishes of young Mothers to have a fenced area at Henley Park for their small children has been identified to be near the large BBQ area closest to the Edenhope College. They just want to keep a close eye on their children while they enjoy a picnic, family reunion, a friends' gathering, or programs that other organisations provide.

We would expect that WWS Councillors and staff's position of great importance when considering the historic values related to our Aboriginal Cricket History. Aborigines walked along the shores of Lake Wallace to play and practice the art of cricket, including the foreshore grassed area of Henley Park.

<u>Lions Park</u> has been identified as the main play space for families, friends, visitors, & tourists. Edenhope tourist group are witness to many visitors and locals who occupy the BBQ area and play equipment at this park. It is in need of a toilet only and a <u>slippery slide</u> which was asked for 8 years ago by a young local male who still wants a slippery slide.

A face-to-face meeting with all stakeholders including the Police about the position of the toilet in Lions Park would be a positive outcome. The plan sees a toilet adjacent to the Police Station. (Court day is a busy day with the public).

The reasons we don't want changes to the Lake Wallace foreshore and the road closure access from Anzac Ave and Tom Wills Drive.

- 1. Henley Park is an Emergency Assembly Area.
- 2. How will the Emergency Services access some-one who has had a health event (Heart Attack) on the pier or in the vicinity of. How does the public access the Emergency First Aid at the current toilet site if the road is blocked.
- 3. The schools emergency evacuation site is Henley Park.

Edenhope -Home of Australia's First overseas Touring Cricket team in 1868. (Edenhope 150 years Celebrations 2008 pg 15).

- 4. The passage to where the Aboriginal Cricketers walked was on the shores of Lake Wallace in the vicinity of Henley Park and the Edenhope College.
- 5. Closing this to a play space we believe to be disrespectful and inconsiderate. Henley on Lake Wallace.
- 6. The grassed area has been a viewing point for all water activities on Lake Wallace particularly at Henley on Lake Wallace which has been held for 150 years. 20 years of an empty lake saw the Henley events take place on the Henley oval and foreshore. The end of a full day of activities a concert or band took to the stage to entertain into the evening along with Fireworks which was occupied by onlookers

- 7. When Lake Wallace is full again the Annual Henley Regatta will again focus on the water with water activities. (Edenhope 150 years Celebration 2008 pg 5.)
- 8. The plan to have children's play equipment blocks the view of spectators who enjoy these events.
- 9. Children grow up and leave the district for all reasons. Edenhope is an ageing population who enjoy the most attractive asset they have.
- 10. The Tourism Group are also concerned about non locals who don't live and breathe our communities make suggestions and end up decisions for everyone.
- 11. <u>Leave the current Toilet block where it is.</u> The cost of shifting them is beyond comprehension considering a large amount of money has been spent already through a grant from the government and local monies. Like the old toilets that serviced the past, the new will also survive the future for years to come.

# Draft Submission by Vision & Voice of Edenhope (Progress Association) to the Edenhope Playspace Masterplan

To Sarah,

Vision & Voice of Edenhope wish to present a response to the draft Edenhope Playspace Masterplan. We commend the council in looking at the issue of playspaces in Edenhope, but wish to draw attention to the limits of the project. We originally asked for a Masterplan for Lions Park, and ultimately council decided to do a 'town wide' plan. Our concern is not with the Masterplan idea, but that four playspaces are presented in isolation with each other and the rest of the town. We previously raised concerns with isolated planning approaches in our 2021 budget submission, and our position is unchanged (20.5.21).

Our submission is based on the idea of 'Destination Edenhope' with the plans part of our town, and with a hierarchy based on liveabiltiy for existing residents, followed by engaging new residents, then attracting overnight visitors and then encouraging daytrips.

#### Town-wide approach

We would like to see an introduction page and town map, to acknowledge and highlight that there are many more playspaces in Edenhope, including Lake Wallace, Edenhope Flora Reserve, the school grounds and various sporting centres and that this study is limited to the four playgrounds (with boundaries shown).

Rather than choose one of the four Playspaces to be a priority for investment, we would like to see the priority in key features across the parks and linking the parks. We would like the masterplan to have a time overlay – so we can target key aspects for funding and fundraising rather than confuse what is for now and what for later. If connecting the four parks is outside the scope of the consultants brief, we hope shire staff create this connection as we believe it is important for our town and should be included in the final submission to council.

Our submission is therefore by playspace and by priority.



#### **Lions Park**

A key feature of Lions Park is the undulating landscape, visibility between the playspaces, and the adventure theme, particularly engaging a wide range of age groups at different parts of the playspace safely. Parents are not necessarily close to the children or even necessarily at the park – so encouraging independent play is a key.

#### Agree

- We like the plans for the skate park, slide, new swing, flying fox and formalised carparking at the skatepark. (we did not discuss the climbing cube)
- We support the connecting footpaths (we hope they are wide) around the park (we like the idea there may be traffic marks on them)
- We support more information/education on the frogs and potential artistic links to local wildlife in the park.
- We support signage at the south western side of the park as per the Edenhope Streetscape Plan and Apex Park (the brolgas mural). Directional signage to other assets is also supported (main street, other parks and Lake Wallace).

#### Disagree

- We do not support the move of the Play Activity equipment to the north of the park. It isolates from the rest of the park with line of sight lost (particularly to the skate park) and risks being near the road, also makes the flying fox isolated on the other side).
- We do not support the basketball court having two rings (there are a number of other courts in town) .
- We do not support the 'botanic' branding. Some issues include the condition of some trees (damaged or elderly), inappropriate planting to date, kids are already targeted by magpies (causing distress) and the high value on the line-of site
- We do not support obstruction to the flood control/floodway aspect of the drain (stormwater treatment is most effectively achieved in Back Swamp).

#### Further discussion

- We would like a discussion about the shelter, as we think it could be retained with a revamp in the short term, or moved to work with a public toilet in the general area it is currently situated, but less obstructive.
- We would like to discuss the final toilet location, with our current preference in the south east part of the park (we have been assured that tennis are being supported by bowls). We know every option comes with risks and rewards.
- We would like a more detailed discussion regarding the fish and info shelter before decision on moving or replacement.
- We would like to discuss the tree planting and negative impacts of some shrubbery, with a different approach to future plantings.



#### **Henley Park**

Henley Park is the main all-age gathering space in Edenhope. Importantly, it is the only adult friendly gathering space in town that is not associated with a specific sporting club/activity. It incorporates our 'million dollar view' of Lake Wallace and is the hub of festivals and events (excluding poor weather). The key event is the Henley on Lake Wallace festival, though many parties, markets, concerts, and small gatherings are held most days and weekends. It is popular as a place to eat meals outdoors. It is used regularly by visitors, who may or may not have children. When the lake has water enough for swimming and boating, the foreshore becomes more popular, with more children/families attracted, the pier and the sandy beach become high use areas. Many of our adults are ageing and/or disabled and rely on ease of access to this flat park.

As such, we wish to submit that we do not support a major change to Henley Park at this time.

The changes at Henley proposed are potentially exciting, but they come with many risks too. So for a high cost plan, we may not end up with a better outcome then the important destination we already have. The wide open space of the foreshore welcomes all ages for a wide range of activities. We don't want to lose that with permanent fixtures. Right now families bring their play equipment (often balls) and children play games like chasey and climbing existing trees and structures. We don't need 'destination equipment' to attract people, we already attract people and events, so the priority should be addressing site limitations.

#### Agree

• We agree that a younger child playspace is needed to add to the current uses at Henley. Our preference is it is an enclosed playground along the eastern side of Henley Park Oval. (More below on this).

#### Disagree

We disagree with any short term plans in relation to:

- Closing the service road has the ability to alienate those people who are quite vulnerable and are regular park users. It is a high cost activity.
- There is a concern about the waste of funds on moving a toilet that is new. (Especially now the big tree is gone, so much more of the foreshore is open than 6 months ago)
- Making significant changes to the roads is very costly, and at this stage is not the priority.
- Installing extensive equipment on the foreshore has the potential to exclude other
  users. It re-focuses Henley to be just like the other parks, with children prioritised, and
  even potentially disturbing the older visitors making them feel unwelcome.



- There is the risk that comes from putting moving parts where many gather that they may be damaged or become hazards, particularly during festivals and events, in particular where adults are drinking or children not supervised closely.
- We disagree with further tree planting, with the lake view a key feature of the park.
- Specifically we are concerned that Henley Park's role as a Neighbourhood Safer Place may be jeopardised by the proposed changes, as the fire safe open space is essential, along with access to water and amenities. Closed road and tree planting may impact on this.

#### **Further Discussion**

- Roads and parking: We believe that further discussion is needed regarding the roads and parking. An essential change, not listed, is disabled parking and access. Other than that, it is very high cost to alter that much road space, so significantly more community consultation is needed. One option may be to install bollards to limit traffic to events, as some trialling of options is undertaken. Likewise, additional parking along Charles Lawrence Drive and Top Wills Drive could value add to the park, but needs further work, in particular how long vehicles and caravans will be catered for, currently a high user group.
- Footpath: The footpath changes are needed to link parks, but the circular path in the main lawned area needs more thought, as it potentially causes issues during events and given our preference for a different children's park citing, it changes how parts connect.
- Trees: With the lake view a key aspect of this park, we believe any new tree planting needs further consultation to provide shade and shelter (and future climbing) without obstructing the park. There is plenty of evidence where trees have overtaken their original purpose and become dangerous or obstructive.



#### **Apex Park**

Apex Park is a transitory space, most often used for lunch meals, travellors passing through, students transiting and smaller children with supervision.

#### Agree

- We support the installation of the brolga sculpture
- We support a focus on 'civics' in particular history of the park, farming, the old school and the log (which we support moving to the north west of the park)

#### Disagree

We think the play equipment can stay.

#### Discussion

- This park could be upgraded with discussion with Historical and Tourism groups to interpretive signage to a theme of times past. Attracting funding outside of playspaces may be more feasible.
- This could be the location for the fruit orchard, but further discussion is needed.
- This park is not our priority for major upgrades at this point.

#### **Anne Street**

Anne street is a low impact park that services neighbouring homes and those walking around part or whole of Lake Wallace, so short visitation times are a focus.

#### Agree

- We agree with a nature play theme.
- We agree with new swing.

#### Disagree

We disagree with removing the fitness stations. If children's safety is a concern, and
access, this could be reviewed with better signage and changed edging. The fitness
stations are used by locals doing own rehab and for those who do not want to exercise
at a main park (e.g. body shaming). It is also a change for those walking, particularly
as a family group or sporting group, as they go around Lake Wallace.

#### Discussion

- This park could be upgraded with discussion from Landcare about nature play and the connection with the Lake environment. Other than the single swing that is in poor state, other aspects could be improved at a later time.
- This park is not our priority for major upgrades at this point.



#### **Project Prioritisation**

We would like to see the masterplans has an overlay of priorities, being the top 5 in particular as a package for funding rather than a single park. Depending on ability to fundraise, fund and attract funding, some other priorities could be included.

As we have previously indicated, our group is more than happy to support grant applications and fundraising activities to gain our priorities in a timely way. We are very excited by the opportunity to make Edenhope more liveable and a more popular destination for a range of ages and abilities.

#### **1A Lions Park Toilets**

Our highest priority remains the installation of a toilet at Lions Park. It has bee years that parents are carrying bags for poo and dealing with children weeing behind trees. Adding the toilet provides a basic amenity to the site, but allows people to stay longer and host more activities e.g. parties. It is the biggest problem and quickest fix facing playspaces in town, with budget already allocated and user groups keen for a resolution.

#### 2a Fenced Henley Playground

We would like to see an enclosed playground along the eastern side of Henley Park Oval. Based on play equipment found at Naracoorte playspace. Key features to support young children's safe play with some fixed shaded areas within. The installation of some clear panelling in the existing easterly BBQ shelter would allow supervision during food preparation. Additional seating for parents along it would be appreciated.

This project has the advantages of using what is currently low use area, it is high prominence and value adds to the Henley on Lake Wallace and other festivals with secure and enjoyable children's entertainment space (something that is currently imported in). It also provides a secure easterly fence for the park, reducing burdens for event organisers (safety and ticketing).





#### **2b Adventures at Lions Park**

Additional adventure at Lions Park. We would like to see equipment returned, extended and installed that increases the 'adventure' options for a range of ages as per the Masterplan shown. Key features would be extending the skate ramp for safety and more participants, replacing the large slide/s and installation of a flying fox. Potentially the formalised parking near the skate ramp.

#### 2d Linking within and between parks

In the adventure theme, creating linking paths between the playspaces and within the playspaces increases the fun and connectiveness of the spaces. In Lions Park, riding around the creek makes that space a feature and is safer than the only options currently, which are near the road and/or very steep. Connecting Henley/Lions and other parks with footpaths mean older children are engaged in moving around the town and families can move over time between spaces. In particular a path is needed along Henley Park's southern edge, and along Lake Street between playgrounds (including a short crossing to Anne Street Park from the Lake Street footpath.

Pedestrians could be prioritised with paint. Using zebra crossing lines, pedestrians could be prioritised. Sites would include the Service Road at Henley, Lake Street near Henley Park, Orme Street (near Lake Street). This would hopefully address a number of concerns about safety and connectivity.

We have heard some comment that WWSC is planning to install a connecting footpath from Lions Park to Lake Wallace/Henley Park. We have previously indicated a strong desire to be included in consultation on footpaths, particularly to ensure they make adequate provision for our disabled, young and parenting population. We ask to be involved.

#### 2d Signage and Destination Edenhope

Installing the brolga murals brings together the destination Edenhope theme. Directional signage encourages people to visit the different parks for different reasons and in different ways. The log jinker would need to be moved to its new site as part of this project, as it is in the way. Additional themed equipment could be included in this priority e.g. equipment that looks like a frog, bird or fish.
