**Works on Waterways Application No. WCMA-W-2022-00002**

In response to your application, received by Wimmera CMA on 23 December 2021, to carry out works on a waterway:

Pursuant to *Sections 160, 219 and 287ZC of the Water Act 1989*, Wimmera CMA hereby grants a permit (enclosed) for the proposed works, with specific conditions. The conditions, which are shown on the permit, must be adhered to and any variation to the conditions must first be approved by Wimmera CMA.

Limited evaluation of the works has been carried out to ensure the construction of the structure does not affect the integrity of the waterway or its surrounds. The evaluation does not include the structural soundness of the works to meet your particular service requirement. This remains the responsibility of the applicant.

It is the responsibility of the person issued with this permit to obtain the necessary approval from:

- The relevant planning authority
- The relevant departments in relation to the *Land Act 1958, Forests Act 1958, Flora and Fauna Guarantee Act 1988, the Conservation, Forests and Land Act 1987* and the *Catchment and Land Protection Act 1994*
- The relevant authority in relation to the *Aboriginal Heritage Act 2006*

Approval given by Wimmera CMA may not satisfy those requirements.

Plans and details of the works submitted are generally satisfactory, therefore work may proceed under your supervision or the supervision of a qualified engineer who may be required to certify that the works have been constructed in accordance with your plans.

As part of the approval process, Wimmera CMA may conduct site inspections to monitor the works and assist if required. Please notify Wimmera CMA at least two working days prior to the commencement of any works and within three working days after the completion of works, to arrange inspection times.

3. The extent of the review by Wimmera CMA of the works identified above, has been confined to a limited evaluation of the effect of the works on erosion in the waterway and flooding of adjacent lands and has not included an evaluation of the structural soundness of the works.

## Permit Conditions

1. The works must be undertaken in accordance with the details of the application and these conditions.
2. The person or contractors undertaking these works must be provided with a copy of these conditions.
3. Disturbance of the bed and banks of the waterway and the use of construction plant and equipment must be kept to a minimum during construction. Removal, destruction or lopping of native vegetation must also be kept to a minimum. Suitable conservation measures must be implemented at all times to prevent vegetation, silt, chemicals and spillage from construction activities either entering the waterway or moving downstream. No discharge/dumping of wastewater or other materials to the waterway is permitted, unless specifically authorised by the Authority.
4. Vegetation that has been cleared for construction purposes and any heaps of excavated soil remaining after the completion of works must be removed from site. No material of any sort shall be pushed into the waterway or left in a manner where it can slip or be moved by floodwaters, into the waterway.
5. The Authority is to be notified upon completion of the works or activities.
6. Cut or lopped vegetative material is to be removed completely from the waterway and temporarily stockpiled, and disposed of in a timely and appropriate manner with the agreement of the land manager.
7. The works must be undertaken with machinery that is suitable for excavating material with minimal environmental damage. All undertaken from the bank from the bank.
8. All vehicles and machinery on site must be properly cleaned before arrival at and upon leaving the site.
9. Sites of access tracks in the riparian zone should be selected such that the impact on vegetation is minimal.
10. In the case of access ramps cut into the bank, where runoff from the ramp will flow directly into the waterway, the access ramp must be surfaced with compacted gravel to prevent scour of the track.
