- (a) there are clear reasons for particular matters to remain confidential; or
- (b) a meeting is required to be closed for security reasons; or
- (c) it is necessary to enable the meeting to proceed in an ordinary manner.
- (4) A meeting closed to the public for the reasons outlined in sub-rule 3(b) or 3(c) will continue to be livestreamed. In the event a livestream is not available:
- (a) the meeting may be adjourned; or
- (b) a recording of the proceedings may be available on the Council website

The West Wimmera Shire Council Governance Rules set out the meeting procedure rules for this Council Meeting.

Members of the public are reminded that they are required to remain silent during this meeting.

This Council meeting will be recorded for live streaming.

15.1 Sealing of Section 173 Agreement Crown Allotment 8 Parish of Nateyip, Billy Ho Road, Kaniva

Purpose

To seek a resolution of Councill to use the Common Seal of Council to complete a Section 173 Agreement for Crown Allotment 8 Parish of Nateyip, Billy Ho Road, Kaniva.

OFFICER RECOMMENDATION:

That Council authorise the use of the Common Seal of Council for the signing of the Section 173 Agreement for Crown Allotment 8 Parish of Nateyip, Billy Ho Road, Kaniva.

Declaration of Interest

No officer declared an interest under the Local Government Act 2020 (LGA 2020) in the preparation of this report.

Background

Planning Permit PA1170 is an application to subdivide an existing property into two lots.

As the subdivision creates a lot boundary through an area of native vegetation, the permit is needed to address the matter of consequential loss of native vegetation.

A Section 173 agreement is a legally binding agreement under the Victorian Planning and Environment Act 1987, typically between a landowner and the local council. It is used to impose restrictions or requirements on the use or development of land that are not easily dealt with through traditional planning permits. In the context of native vegetation, the agreement can be used to ensure long-term protection and management of vegetation in lieu of more immediate offset planting requirements.

In this case, the Section 173 agreement related to Planning Permit PA1170 addresses the potential for consequential loss of native vegetation resulting from the subdivision – particularly the potential to clear native vegetation for a boundary fence.

Instead of requiring the applicant to provide immediate offset planting (as typically mandated by the Native Vegetation Regulations 2017), the agreement would commit the





applicant to a set of land management obligations that protect or enhance existing native vegetation on-site.

By entering into this agreement, this arrangement represents a significant dollar saving to the applicant, and a better land management outcome for the bushland area contained within the subdivision.

Maddocks Lawyers have reviewed the draft agreement and have advised that it is suitable to proceed. The applicant's Lawyer also concurs with the wording of the agreement.

Signing of the agreement completes the actions required by the conditions of the planning permit, and the matter can then proceed to issuing of the Statement of Compliance.

In summary, the Section 173 agreement removes the immediate requirement for offset planting by providing a legally enforceable framework for managing the vegetation in a way that compensates for its loss. This approach can be more flexible and sustainable while still meeting the regulatory goals of protecting biodiversity and managing land in accordance with native vegetation laws.

Signing of the agreement completes the actions required by the conditions of the planning permit, and the matter can then proceed to issuing of the Statement of Compliance.

Background

On 17 May 2023, Council resolved to seek authorisation from the Minister for Planning to prepare an exhibit Planning Scheme amendment C37wwim.

The amendment was exhibited on Thursday 18 July 2024. No submissions were received.

Amendment C37wwim is a policy neutral amendment that makes a number of changes to the Planning Scheme that were identified in the Planning Scheme Review, and does not make any changes to the use and development rights for any land.

The changes that are being made to the West Wimmera Planning Scheme have already been presented to Council as part of the Planning Scheme Review.

The amendment was prepared with the assistance of the Department of Transport and Planning's Planning Hub assistance program.

Once Council has adopted the amendment, it can be forwarded to the Minister for Planning for their consideration, prior to gazettal. There is no further work required for this amendment.
